

Singapore Rollersports Federation Discipline: Skateboarding

33rd Southeast Asian (SEA) Games Bangkok, Chonburi & Songkhla, Thailand 9 to 20 December 2025

1. GOALS & OBJECTIVES

To achieve a podium finish in at least 25% of events contested in.

2. SELECTION COMMITTEE

The SRF Selection Committee will be made up of the following members:

- Kevin Mok (Vice President, Boards and Park Discipline, SRF)
- Nicholas Ferguson (Vice President, Certifications, SRF)
- Zulkarnaen Mohd Zin (Discipline Head, Skateboarding, SRF)

3. ELIGIBILITY & CONSIDERATION PERIOD

All athletes must be Singapore Citizens and should not be holding dual citizenship if they are above 22 years old, at the time of nomination; and fulfil eligibility under the regulations from the Olympic Council of Asia and Singapore Rollersports Federation.

4. CATEGORIES INCLUDED IN THE 33rd SOUTHEAST ASIAN (SEA) GAMES 2025

- i. Park (Men & Women)
- ii. Street (Men & Women)

5. SELECTION CRITERIA

i. Identifying athletes for Long List

a) All interested athletes are to participate in the National Championships sanctioned or organised by Singapore Rollersports Federation between 31st March 2025 and 5th September 2025 in order to facilitate the shortlisting of potential candidates.

- b) Athletes who have attained top 6 in the National Championships, will be invited to the National Training Squad and will be shortlisted for SEA Games selection if they also meet SNOC's Selection Criteria.
- c) Athletes who are currently ranked Top 10 in Southeast Asia will also be invited to the National Training Squad.
- d) All interested athletes will be assessed on skill level, technical expertise and level of precision in execution. Those who are selected will be required to commit to training schedules set down by the coaching staff and must meet a minimum of 80% attendance for all training.
- e) All athletes who meet the above criteria will be considered for the Long List selection which will then be submitted to SNOC for review, and to be nominated for SEA Games selection based on the assessment of the athlete's potential to achieve podium success at the Games.

ii. Other Considerations

In addition to the above selection criteria, the following qualities of the athletes will be taken into consideration:

- *a)* Attitude and behaviour towards coaches, teammates, fellow athletes, officials and sports administrators, *whether in relation to sporting matters or otherwise*
- b) General conduct **and character** which may affect the reputation, image, values or best interests of the athlete or the sport
- c) Past disciplinary record
- d) Current skill level and fitness; and character
- e) Level of commitment and attendance
- f) Potential for future development
- g) Ability to demonstrate team spirit and work well with teammates and officials; and
- h) Such other non-performance related qualities as the selectors may consider to be relevant.

iii. Extenuating Circumstances

In consideration of the performance and "qualities" of athletes, the selectors may at their discretion give consideration to extenuating circumstances. For this purpose, "extenuating circumstances" mean an inability of the athlete to compete in and/or attend event, training camps or other required attendances arising from:

- a) Injury or illness
- b) Equipment failure

- c) Travel delays
- d) Bereavement; and
- e) Such other circumstances as the selectors may consider to be relevant

iv. Criteria for SNOC Nomination

Nominations for SEA Games Selection will be based on the Long List where:

a) Athletes who have currently achieved at least <u>3rd placing</u> e.g. time/distance/score/mark of the 2023 SEA Games. As Skateboarding was not featured at the 2023 SEA Games, SRF will use the 6th placing scores from the 2022 Asian Games as benchmark for athlete nomination.

- b) Athletes who miss the qualifying standard marginally but show potential to equal or surpass it in time for the Games. This will include athletes who have shown ability to achieve a score that is within 5% to the 6th placing scores in the 2022 Asian Games.
- c) All achievements will be assessed on a score-based benchmark primarily with Head-to-Head results serving as supporting information.
- d) All achievements submitted for consideration should have taken place at international competitions sanctioned by the International and/or Regional controlling bodies, but NSAs may submit the achievements from overseas championships and meets of athletes studying in overseas tertiary institutions. However, these have to be properly accredited and sanctioned to be accepted.
- e) All achievements should be achieved from 31st March 2025 up to 5th September 2025, which is 2 weeks before 19th September Entry by Name deadline, as the nominations have to be submitted to the SNOC Appeals Committee for approval before the deadline.
- f) Pursuant to the Olympic Charter (By laws to Rules 27 and 28, paragraph 2.1), "Selection shall be based not only on the sports performance of an athlete, but also on his ability to serve as an example to the sporting youth of his country."

6. SELECTION PROCESS

- i. The selection policy will be published at <u>https://www.rollersports.org.sg</u>.
- ii. There will be an SRF Selection Committee to assess and select athletes for nomination to SNOC.
- iii. The SNOC Selection Committee will meet in July 2025 (subject to the Organising Committee's confirmation of the Accreditation deadline) to discuss the nominations from NSAs and select athletes/teams for the Games.
- iv. Two months before the deadline for submission to SNOC, the SRF Selection Committee will be convened to select the players based on the above criteria.
- v. Athletes who are selected for 33rd Southeast Asian (SEA) Games must fulfil training requirements set by SRF and the SRF Selection Committee.
- vi. The SRF Selection Committee reserves the right to change the nomination for the team before the SEA Games Team Managers' Meeting. Changes in nomination can result from situations including but not limited to athlete injury, change in legal status, athlete surrendering their position/selection status or athletes not conforming with the rules and regulations set down by governing bodies. Any changes made to the nomination of athletes to SNOC must be made before SNOC's selection and/or appeals deadline and replacement athletes must be selected from the Long List. Any athletes not included in the initial selection will not be considered.
- vii. For Entry By Name submission, SRF can select the final list of athlete(s) from those selected by SNOC selection/appeal committees. Athletes not selected by SNOC will not be considered. If the number of athletes deemed eligible exceeds the event entry limits, SRF will conduct a selection trial event to determine which athletes will proceed.
- viii. For athlete replacements after the Entry By Name deadline, only athletes previously selected by SNOC selection/appeal committees can be considered as replacement athletes. Any replacements are subject to the conditions of late athlete replacement set by the event organiser.

7. CODE OF CONDUCT

- i. All athletes are to consider themselves Ambassadors of Singapore and are expected to behave with dignity and respect at all times.
- ii. All athletes will be expected to follow the rules set down by SNOC and the governing body of the 33rd Southeast Asian Games. This includes attending all

scheduled events, opening ceremonies and award presentations unless excused by team management.

- iii. All athletes will be expected to respect the host country's customs, traditions and laws and avoid actions that could be seen as disrespectful or offensive to the host nation.
- iv. All athletes will be expected to use social media responsibly, refraining from posting offensive, discriminatory, or negative content about the competition, host country, or other participants.
- v. Athletes will be expected to abide by team obligations. This includes attending all team meetings, debriefs, and scheduled activities, communicating openly with team officials about health, injuries, or personal concerns and wearing team uniforms as instructed during official events and ceremonies.
- vi. The penalty may include the athlete having to bear the total cost of the event (travel, hospitality and entry fees). There may be further action such as suspension from future local and overseas competitions based on the severity of the incident.
- vii. The team will be managed by SNOC and the CDM at the Games. If there are any disciplinary cases, SRF will convene a Disciplinary Committee to investigate and verify any breaches of conduct and will report any findings and subsequent consequential actions to SNOC.
- viii. SNOC will also convene a Disciplinary Committee to investigate and decide on the sanctions.

8. APPEAL PROCESS

- i. An appeal against the non-selection must be made in writing to the President of the Singapore Rollersports Federation (SRF) via email to appeal@rollersports.org.sg within 48 hours of the announcement of the athletes selected for the SEA Games.
- ii. Grounds for any appeal is that:
 - SRF has failed to properly apply the eligibility and selection criteria set out in this policy
 - Existence of fresh and compelling evidence and/or data which had not been submitted in the initial nomination
- iii. An appeal must be made in writing with supporting documents and must be accompanied with a deposit of S\$100.00, payable to the Singapore Rollersports

Federation. The deposit will be fully refunded in the event that the appeal is successful.

- iv. There will be an Appeal Committee from the SRF (comprising of members not involved in the actual selection process) to review the appeal with all involved parties. The members of the SRF Appeal Committee are:
 - a. Eddie Chua (President, SRF)
 - b. Kenny Lam (Vice President, SRF)
 - c. Vickneswaran s/o Somu Thevar Ramadoss (Assistant Secretary-General, SRF)
- v. SRF will, in writing, inform all parties about the Appeal Committee's decision to either uphold or reject the appeal. The decision of the Appeal Committee will be final, and no further correspondence will be entertained.
- vi. Nomination of Selection & Appeals Committee committee members are eligible to be on the committee provided they do not have any family members or relatives in the selection pool. Any member of the committee must disclose any potential conflict of interest before the committee is formally convened. If a conflict of interest is found to be valid, that member must recuse themselves from any relevant decisions. Nominees will be announced (if required, i.e. no clear nomination, subjective appeals) subject to panellists work exigencies, and will be made known to athletes in due course.
